PSOA ANNUAL SUBSCRIPTION POLICY

1. Annual Subscription Fee

The annual subscription fee as approved by the PSOA Council is as follows:

Membership Level	Category A	Category B
Fellow	Rs. 25,000	Rs. 10,000
Associate	Rs. 10,000	Rs. 5,000
Student (Employed)	Rs. 2,500	Rs. 2,000
Student (Not Employed)	Rs. 1,000	Rs. 1,000

Category A: This includes members with their actuarial practice in Pakistan in any capacity.

Category B: This includes members residing and practicing outside Pakistan.

Membership year runs from July 1 to June 30 next year. The annual subscription fee as given above will be due on July 1 each year.

2. Late Payment and Non-Payment

Fee unpaid as of September 1, 2015* Late penalty of 20% of the Member's Fee Fee unpaid as of December 1, 2015 Membership suspension

3. Waiver or Reduction of Fees

Following members will be exempted from annual subscription fee:

- a. Age 70 or above;
- b. Retired and Age 55 or above.

Council may exempt or reduce fess for any member under special circumstances upon request.

4. Restrictions under Suspension

- a. Members will be barred from using the FPSA or APSA titles;
- b. Members will not be eligible for any discounts offered to PSOA members;
- c. Members will not be eligible for material exclusive to PSOA members.
- d. Category A Fellows and Associates will be charged a significantly higher fees for PSOA Seminars/ Conferences.

5. Reinstatement

Conditions for reinstatement are as follows:

- a. Member to submit a written request to the Secretary stating the reason for non-payment;
- b. Request for reinstatement will be reviewed and approved by the Council;
- c. Payment of outstanding dues including late fee (total payment for a maximum of 2 years);
- d. Payment of any current dues.
